## **Project Update**

Verbrec today confirms that it has applied to the registrar for adjudication of client assessment of a payment claim in accordance with the Building Industry Fairness (Security of Payment) Act 2017 (QLD) (the **Act**).

The Claimant alleges that the Respondent has not assessed the payment claim in accordance with the terms of the Contract and has taken the step of applying for adjudication under the Act in order to recover a portion of the payment claim submitted on 20 September 2022 totalling \$906,553.52 excluding GST. This application may be the first of several related to this Contract.

The Prior Announcement detailed the submission by Verbrec of its intention to terminate the contract related to the SCADA Upgrade Solution Delivery Agreement. Verbrec has not received a formal response to its notice from Service Stream Utilities Pty Ltd.

Verbrec has not terminated the contract at this time, however, retains its rights to do so.
