- Verbrec awarded \$4.2 million contract by Flinders Ports to undertake M Berth Facility Electrical System Redevelopment Project.
- Prior engineering and design phase successfully completed by Verbrec leading to negotiation and award of construction phase of the project.
- The works are a significant upgrade to the electrical and control system infrastructure at the M Berth Facility located at Inner Harbour, Port Adelaide.

Verbrec Limited (ASX : VBC) (**Verbrec** or the **Company**) is pleased to announce the award of a contract by Flinders Ports to undertake the Electrical System Redevelopment Project at the M Berth Facility located at Inner Harbour, Port Adelaide.

M Berth Facility is a bespoke critical facility for bulk liquid customers for oil and fuel unloading into South Australia.

The value of the contract is \$4.2 million. The works are set to commence from December 2024 and expected to be completed by April 2026. There is opportunity for accelerated delivery should additional access windows arise.

The works consist of rehabilitation of electrical and fire control systems, hazardous area equipment, electrical distribution and main switchboards at the M Berth Facility. The scope includes demolition, fabrication, supply, installation, refurbishment, monitoring, inspecting, testing, quality assurance and commissioning.
